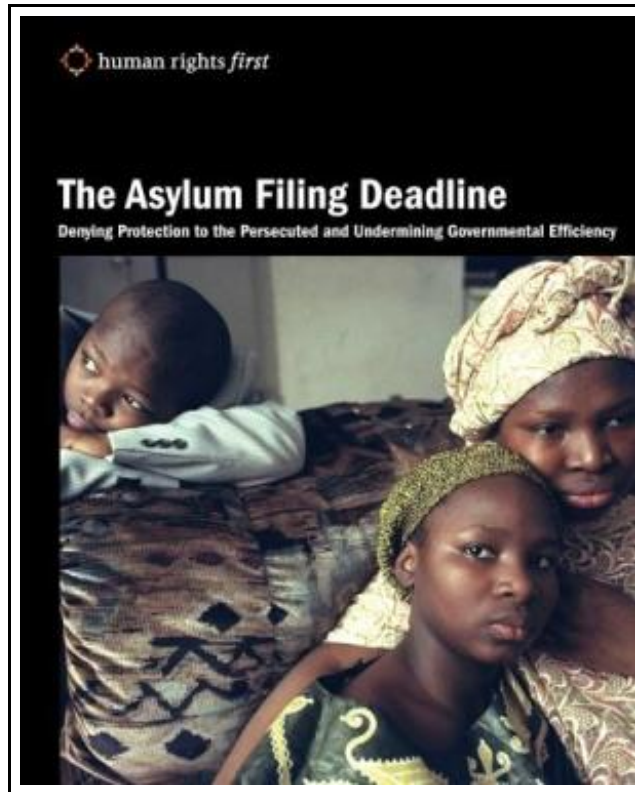

The report finds that in the 12 years since the provision took effect, more than 53,400 asylum applications have been rejected, denied or delayed based on the deadline and many of these cases have been pushed unnecessarily into the already overstretched immigration court system. The report uses real case examples and Human Rights First's own refugee representation experience to demonstrate the harmful effects of the provision. That provision has consistently denied asylum to persecuted individuals in ways that are inconsistent with the nation's leadership in protecting victims of political, religious and other forms of persecution and has caused inefficiencies and delays in the asylum system and diverted significant governmental resources.
